<u>Litigation - Hardesty</u>

Town Attorney John Leidy reported on the status of the Hardesty house which is the last house on Surfside Drive - in this situation the Town is the claimant - the Hardesty house is still a viable structure and is currently being rented. Current value of the property is \$154,700.

Attorney Leidy stated for the record that this situation does not pertain to the Toloczko litigation in which his firm, Hornthal, Riley, Ellis, and Maland, does not represent.

Attorney Leidy recommended that the Town seek resolution in the Hardesty litigation - but to pay them nothing. As a resolution, they are to remove the sandbags which would allow the Town to nourish the beach in this area.

Mayor Oakes expressed concern that the Hardesty property is located on the public trust beach which is why it was declared a nuisance and why the Town eventually sued in order to have it removed.

MOTION: Comr. Sadler made a motion that the Town will drop its lawsuit against the Hardestys on the following conditions:

- The Town is to receive an executed Beach Nourishment Project easement from the Hardestys
- They are to remove their sandbags
- The Town is to receive beach nourishment in this area

The motion was seconded by Comr. Cahoon which passed 3-1 with Mayor Oakes casting the NO vote (Comr. Remaley was not present.).

Nuisance structure litigation - George Moore

Town Attorney John Leidy reported that George Moore and Patricia Moore, owner of several oceanfront nuisance structures, have submitted a letter to the Town requesting that the Town handle removal of two (2) of his houses: 9701j Nansemond Street and 119 Proteus Street. Mr. Moore's letter read in part as follows:

"January 24, 2011

To:

Cliff Ogburn, Town Manager

From:

George Moore

Subject:

Removal of Houses

'As you know, we have made several attempts to have the houses, 9701j Nansemond St and 119 Proteus St moved but to no avail. We did, however have the house at 9209a Old Oregon Inlet moved as requested by the Town.

'My purpose in writing is to ask the Town to handle the removal of the above listed two houses as financially I am unable to handle the removal costs.

'This financial situation I am in was caused by the loss of the income from these three rental houses and the burden of the mortgages which are still due to the banks. We would greatly appreciate the Town's help in this matter."

Attorney Leidy explained that the Board is to consider 1) accepting the offer from co-owner Neal for \$4,500 of the attorney fees due, 2) removing the houses, and 3) requesting a consent judgment for the remainder of the fees due. It was suggested that the Town burn the structures, if possible, in order to greatly reduce the tipping fees.

MOTION: Mayor Oakes made a motion to approve the offer as submitted and to waive the fees on the two houses at 119 Proteus and 9701j Nansemond with a response deadline from Mr. Moore of five (5) business days. The motion was seconded by Comr. Cahoon which passed unanimously.
